RE: Resolution No. 2017-024: NOACA SFY 2018 – 2021 Transportation

Improvement Program

ACTION REQUESTED

The Board of Directors is asked to approve the SFY 2018 - 2021 Transportation Improvement Program (TIP).

The Planning and Programming Committee recommends this action. Also, the Finance and Audit Committee recommended the TIP financial plan for NOACA administered funds at its May 12th meeting.

BACKGROUND/JUSTIFICATION

The TIP contains the program of projects for SFY 2018 through SFY 2021, including projects to be funded with NOACA administered Surface Transportation Block Grant (STBG), STBG setaside for Transportation Alternatives (TAP) and sub-allocated Congestion Mitigation Air Quality (CMAQ) funds and projects financed with other federal funds.

NOACA develops a four year TIP on a biennial basis. TIP development is conducted in coordination with the development of the statewide State Transportation Improvement Program (TIP). As a result of this coordination, several iterations of the draft TIP are developed in advance of NOACA Board adoption of the final.

A first draft of the TIP was submitted to ODOT, FHWA and FTA in February 2017. NOACA developed a second draft TIP for statewide STIP public participation, which ran from March 27, 2017 to April 9, 2017. During the statewide STIP public participation, NOACA participated in the ODOT open houses to invite public review and comment on the STIP/TIP.

In accordance with NOACA's Public Interaction Policy (2015 Update), the NOACA TIP was required to be available for review and comment through May 28, 2017, but is available for public review and comment until the Board of Directors meeting on June 9, 2017.

During the month of May, NOACA held public meetings in each of NOACA's five (5) counties to invite public review and comment of the draft SFY 2018 - 2021 TIP as well as AIM Forward 2040, NOACA's Long-Range Transportation Plan, and the Overall Work Program.

FINANCIAL IMPACT

Projects Programmed with NOACA Administered Funds

The TIP includes a total of \$133.2 million over the four year period. However, because of the inclusion of prior commitments, NOACA's estimated available resources for SFYs 2018 – 2021 is \$55.2 million, (inclusive of \$48.4 million of STBG funds and \$6.8 million of TAP funds). This compares to identified needs that included 323 projects with an estimated total cost of \$476 million.

Based on the availability of funds, projects were prioritized according to regional benefits, impact/connectivity and readiness factors as contained in the 2016- 2019 TIP Development Methodology - Implementing Connections⁺ 2035 and through NOACA transportation asset management planning.

The program of projects recommended to be funded with NOACA STBG, TAP and CMAQ funds for SFYs 2018 through 2021 was developed by staff and recommended by the respective committees and incorporated into the final draft.

The draft lists of projects programmed with NOACA-controlled funds appear in the attached tables. These include projects recommended for:

- NOACA STBG funds
- TAP funds
- Statewide Congestion Mitigation Air Quality (CMAQ) funds

CONCLUSION/NEXT STEPS

Following Board approval, the SFY 2018 - 2021 TIP will be submitted, along with Board resolution of approval, for ODOT, FHWA and FTA review and approval effective July 1, 2017.

RESOLUTION NO. 2017-024 (SFY 2018 - 2021 TRANSPORTATION IMPROVEMENT PROGRAM)

RESOLUTION OF THE BOARD OF DIRECTORS OF THE NORTHEAST OHIO AREAWIDE COORDINATING AGENCY

WHEREAS, the Northeast Ohio Areawide Coordinating Agency (NOACA), as the metropolitan planning organization (MPO) for the five Northeast Ohio counties of Cuyahoga, Geauga, Lake, Lorain, and Medina, is presently engaged, through Board of Directors action and staff technical work, in the continuing phase of the cooperative, comprehensive, and continuing (3C) planning process designed to meet needs, requirements, goals, and objectives of national, state, and local governmental levels, all within this nation's federal transportation system; and

<u>WHEREAS</u>, the Congress of the United States, through law, and the U.S. Department of Transportation, through regulation, have determined that a Transportation Improvement Program (TIP) shall be prepared, which includes federal-aid transportation projects expected to be implemented in each of the program years; and

WHEREAS, the final draft of NOACA's State Fiscal Year (SFY) 2018-2021 Transportation Improvement Program (TIP), dated April 2017 was prepared in conformance with the NOACA Regional Transportation Investment Policy and, as such, is consistent with the above guidance and regulation; and

<u>WHEREAS</u>, the final draft TIP was prepared and submitted for ODOT, FHWA and FTA review and approval.

<u>WHEREAS</u>, the final draft TIP has been processed through public involvement, consistent with the Board of Directors Public Interaction Policy and Participation Plan; and

<u>WHEREAS</u>, the final draft TIP includes projects recommended to be funded with NOACA administered Surface Transportation Block Grant (STBG), STBG set-aside for Transportation Alternatives (TAP) and Statewide Congestion Mitigation Air Quality Program (CMAQ) funds for SFYs 2018 through 2021;

WHEREAS, concurrent with the development of the TIP, PID No. 80974 (CUY TRANSPORTATION BLVD), is being processed through project planning review and, if approved, is to be included in the final TIP; and

WHEREAS, the Clean Air Act Amendments of 1990 require that NOACA make a determination, in cooperation with AMATS, ERPC and ODOT, that the SFY 2018 – 2021 TIP is in conformity with respect to Ohio's State Implementation Plan for attainment of the 2008 8-hour ozone standard and the 1997 annual and 2006 daily fine particulate matter standards; and

<u>WHEREAS</u>, NOACA staff have completed the necessary transportation conformity analyses for the five counties and combined them with the analyses for the rest of the applicable nonattainment areas; and

<u>WHEREAS</u>, the results of the analyses (Attachment 1) demonstrate that NOACA's long-range transportation plan, AIM Forward 2040 and the SFY 2018 – 2021 TIP for the area remains in conformance with the intent of Ohio State Implementation Plans (SIPs); and

RESOLUTION NO. 2017-024 (SFY 2018 - 2021 TRANSPORTATION IMPROVEMENT PROGRAM)

<u>WHEREAS</u>, in accordance with Moving Ahead for Progress in the 21st Century (MAP-21), NOACA and ODOT are carrying out their responsibilities under applicable provisions of federal law.

<u>NOW, THEREFORE, BE IT RESOLVED</u> by the Board of Directors of the Northeast Ohio Areawide Coordinating Agency, consisting of forty-five principal officials of general purpose local government throughout and within the counties of Cuyahoga, Geauga, Lake, Lorain, and Medina that:

<u>Section 1</u>: The NOACA SFY 2018-2021 Transportation Improvement Program, in substantial form, as shown as of today's date on the NOACA website, <u>www.NOACA.org</u>, is adopted as NOACA's TIP.

<u>Section 2</u>: The urban transportation planning process is being carried out in conformance with all applicable federal requirements.

<u>Section 3</u>: The Executive Director is hereby authorized to transmit a certified copy of this resolution and other appropriate documentation to federal, state, and local agencies.

Ozone and PM2.5 Conformity Analyses for Transportation Plans, Programs, and Projects in the Cleveland-Akron-Lorain, Ohio Metropolitan Area

Akron Metropolitan Area Transportation Study (AMATS)
Northeast Ohio Areawide Coordinating Agency (NOACA)
City of Vermilion, Lorain County portion

What is required?

Nonattainment areas, through a process called transportation conformity, are required to demonstrate that emissions resulting from planned transportation system improvements will not exceed an area's emissions budgets. The US Department of Transportation (US DOT) issues nonattainment areas formal transportation conformity determinations following a quantitative analysis demonstrating that emissions from vehicles traveling on the planned transportation system are less than the area's emissions budget (or other emission target in the absence of an approved budget). Transportation conformity determinations ensure that the transportation sector is contributing to an area's progress toward meeting national air quality standards.

The Metropolitan Planning Organizations (MPOs) and the Ohio Department of Transportation (ODOT) must reestablish conformity for the 2006 and 2012 fine particulate matter (PM_{2.5}) standards and for the 2008 8-Hour ozone standard as a result of the adoption of SFY 2016-2019 Transportation Improvement Programs and long range transportation plan amendments. Because conformity is determined on a nonattainment area, rather than a sub area basis, each of the area's planning partners must approve a new conformity finding for the area based on these updates. The analysis for each standard covers the pertinent portions of the counties of Ashtabula, Cuyahoga, Geauga, Lake, Lorain, Medina, Portage and Summit. The current analyses reflect a comparison of projected transportation emissions against the approved budgets for each standard.

Why are these tests required?

These tests are required because all areas with a current or former designation of nonattainment must maintain conformity findings for the designated pollutants. The tests ensure that transportation planning efforts are not hindering efforts to bring the area into attainment of the standards or maintain attainment of the standards.

What tests are being conducted?

The first test is a comparison of projected emissions against the draft budgets for ozone precursors (volatile organic compounds (VOCs) and nitrogen oxides (NO_x)).

The second test is a comparison of projected emissions with draft budgets for PM_{2,5} and NO_x.

For all tests, projected emission levels beneath the respective budgets is considered conformance with the goals of the Clean Air Act.

What are the results of the tests?

The results of the tests, as displayed in the following Tables, are that the area's existing plans, programs, and projects meet the conformity requirements.
