RE: **Resolution 2018-010 – Plan and TIP Amendments – 3rd Quarter State Fiscal Year (SFY) 2018**

ACTION REQUESTED

The Board of Directors is asked to approve the amendment of NOACA's long-range transportation plan (Plan) and the Transportation Improvement Program (TIP) to include the proposed projects as indicated.

The Transportation Subcommittee and Planning and Programming Committee have recommended this action.

BACKGROUND/JUSTIFICATION FOR CURRENT ACTION

The proposed amendments to the Plan and the state fiscal year (SFY) 2018 – 2021 TIP include roadway and transit projects sponsored by the Ohio Department of Transportation (ODOT), the Greater Cleveland Regional Transit Authority (GCRTA) and Laketrans. These projects are being processed through project planning review (PPR).

The proposed amendments also include a project that has been processed through PPR and is currently on the Plan. The project, sponsored by the Cuyahoga County Department of Public Works (CCDPW), involves the reconstruction of Royalton Road, in North Royalton (CUY SR 82 - 4.83: PID No. 80961). The project is being advanced from the Plan to the TIP. Financing for the project has been secured. In accordance with federal regulations, advancing the project from the Plan to the TIP requires a resolution.

The amendments also include two Lorain County Transit (LCT) sponsored projects, being carried over from the previous TIP to the SFY 2018 - 2021 TIP, which requires a resolution.

Also included in the amendments are modifications to five other LCT projects to reflect changes in maintenance expenses, operating assistance, preventive maintenance and Lorain County receiving contracts with Lorain County Job and Family Services to provide non-emergency medical transportation and to Lorain Metropolitan Housing Authority. The modified costs exceed the cost estimate threshold, which also requires a resolution.

FINANCIAL IMPACT

The cost of the proposed projects being amended to the Plan and TIP is \$75.6 million, of which \$15.9 million is NOACA funds. Funding for these projects is committed and/or planned from a variety of federal, state, and local sources. Federal funding is provided by the Federal Highway Administration

and the Federal Transit Administration and is administered through the Ohio Department of Transportation.

CONCLUSION/NEXT STEPS

With Board approval, the amendments will be incorporated into the NOACA Plan and/or statewide TIP amendment in April 2018.

**RESOLUTION OF THE BOARD OF DIRECTORS
OF THE
NORTHEAST OHIO AREAWIDE COORDINATING AGENCY**

WHEREAS, the Northeast Ohio Areawide Coordinating Agency (NOACA) is the Metropolitan Planning Organization (MPO) for the counties of Cuyahoga, Geauga, Lake, Lorain, and Medina, and the City of Cleveland; and the areawide water quality management agency for the same region; and

WHEREAS, the Congress of the United States, through law, and the U.S. Department of Transportation, through regulation, have determined that MPOs shall create a long-range, 20-year transportation plan and a four-year Transportation Improvement Program (TIP) that list federal-aid transportation projects expected to be implemented in each of the program years; and

WHEREAS, the NOACA Board of Directors' Regional Transportation Investment Policy requires that all proposed federal-aid transportation projects be processed through project planning review in order to meet transportation plan goals and federal requirements; and

WHEREAS, the following projects are proposed amendments to the NOACA long-range transportation plan (*AIM Forward 2040*) and state fiscal year (SFY) 2018 - 2021 TIP:

- a) Cuyahoga County Department of Public Works: CUY SR082-04.83: PID No. 80961 - The proposed project involves reconstruction, including a center turn lane, from West 130th Street to York Road, in North Royalton.
- b) Ohio Department of Transportation (ODOT): GEA US 322-7.78: PID No. 106261 - The proposed project involves modifications and improvements to the intersection of US-322 and Auburn Road, in Munson Township.
- c) Ohio Department of Transportation (ODOT): GEA SR 608-3.09: PID No. 103884 - The proposed project involves widening the shoulders on SR-608 (Old State Road), from Nauvoo Road to approximately 2,500 feet north of Burton Windsor Road, in Middlefield Township.
- d) Greater Cleveland Regional Transit Agency (GCRTA), FY 2018 Capital Grant Program - GCRTA is adding two new projects to its Federal fiscal year (FFY) 2018 program and moving two projects back to future years. GCRTA is revising and amending its FFY 2017 Capital Formula, FFY 2017 State of Good Repair, FFY 2016 Capital Formula and FFY 2016 State of Good Repair grant programs to re-allocate project funds to address under-runs, over-runs, and revised project priorities impacting 12 TIP projects. GCRTA is also adding two projects, previously in the SFY 2016 - 2019 TIP, to the current SFY 2018 – 2021 TIP due to delays in receiving timely environmental approvals.
- e) LAKETRAN: FY 2018 Capital Program Revisions: The program revision involves removing the project to expand an existing park and ride lot, located at Market Street and Munson Road, in Mentor (PID No. 83102) and redirecting the project's \$388,000 of CMAQ funding to the purchase of replacement commuter buses under the LAKETRAN 2018 MCI COMMUTER BUSES PID No. 99122).
- f) Lorain County Transit (LCT) FY 2018 - 2020 Capital Program: - Amendments to the LCT program include two projects carried over from the previous TIP to the SFY 2018 - 2021 TIP and modifications to five projects to reflect changes in maintenance expenses, operating assistance, preventive maintenance and contracts with Lorain County Job and Family Services to provide

non-emergency medical transportation.

WHEREAS, the above projects are excluded from regional emissions analysis and as such do not affect the existing plan and TIP's air quality conformity determination; and

WHEREAS, the above projects are consistent with current financial forecasts and plans; and

WHEREAS, it is expected that the project sponsors will, in good faith, endeavor to address comments and recommendations raised during project planning review and will provide evidence of such, prior to the project advancing; and

WHEREAS, the above projects are recommended by the Transportation Subcommittee (TS), Planning and Programming Committee and the Executive Committee as amendments to the Plan and TIP as appropriate.

NOW, THEREFORE, BE IT RESOLVED by the Board of Directors of the Northeast Ohio Areawide Coordinating Agency, consisting of 45 principal officials serving general purpose local governments throughout and within the counties of Cuyahoga, Geauga, Lake, Lorain, and Medina that:

Section 1: The referenced projects have had appropriate review and are recommended for approval.

Section 2: The NOACA transportation plan and TIP are amended to include the projects for project development and processing review purposes.

Section 3: The Executive Director is authorized to transmit certified copies of this resolution to appropriate federal, state, and local agencies.
