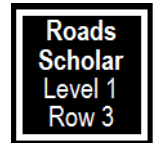

**Description** – This workshop describes the process used by the Ohio Department of Transportation for pavement condition rating (PCR). This process can be used or adapted by local agencies to identify pavement distresses and condition levels. In addition, this workshop includes an outdoor field exercise, weather permitting, for the opportunity to apply the procedure presented as well as discussion of pavement management uses for the data.

**Who Should Attend?** – This course is applicable to local agency employees and others who are responsible for evaluation or management of local roads and streets.

**Please plan to bring a safety vest for the outdoor field exercise.**



**Instructors** – The primary instructor will be Patrick Bierl, P.E., with ODOT's Office of Pavement Engineering. Additional PCR staff from ODOT will also assist with the field exercises for these sessions.

**Registration Information** – This course offering through LTAP is intended primarily for local agency employees (county, city, village and township). **The max. number of seats per session is 20**, due to the field exercise. Registrations are processed in the order they are submitted online, while seats are still available. The registration fee is **\$30 per person for government employees and \$75 for non-government employees**. Lunch is "on your own". No-shows and late cancellations (< 5 calendar days) will be charged the full registration fee. Any registrant requiring a reasonable accommodation during training (i.e., mobility or access) should contact Ohio LTAP prior to the course date so the appropriate arrangements can be made.
