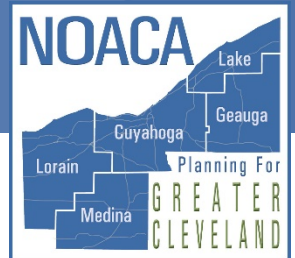
BACKGROUND

The purpose of Project Planning Review:

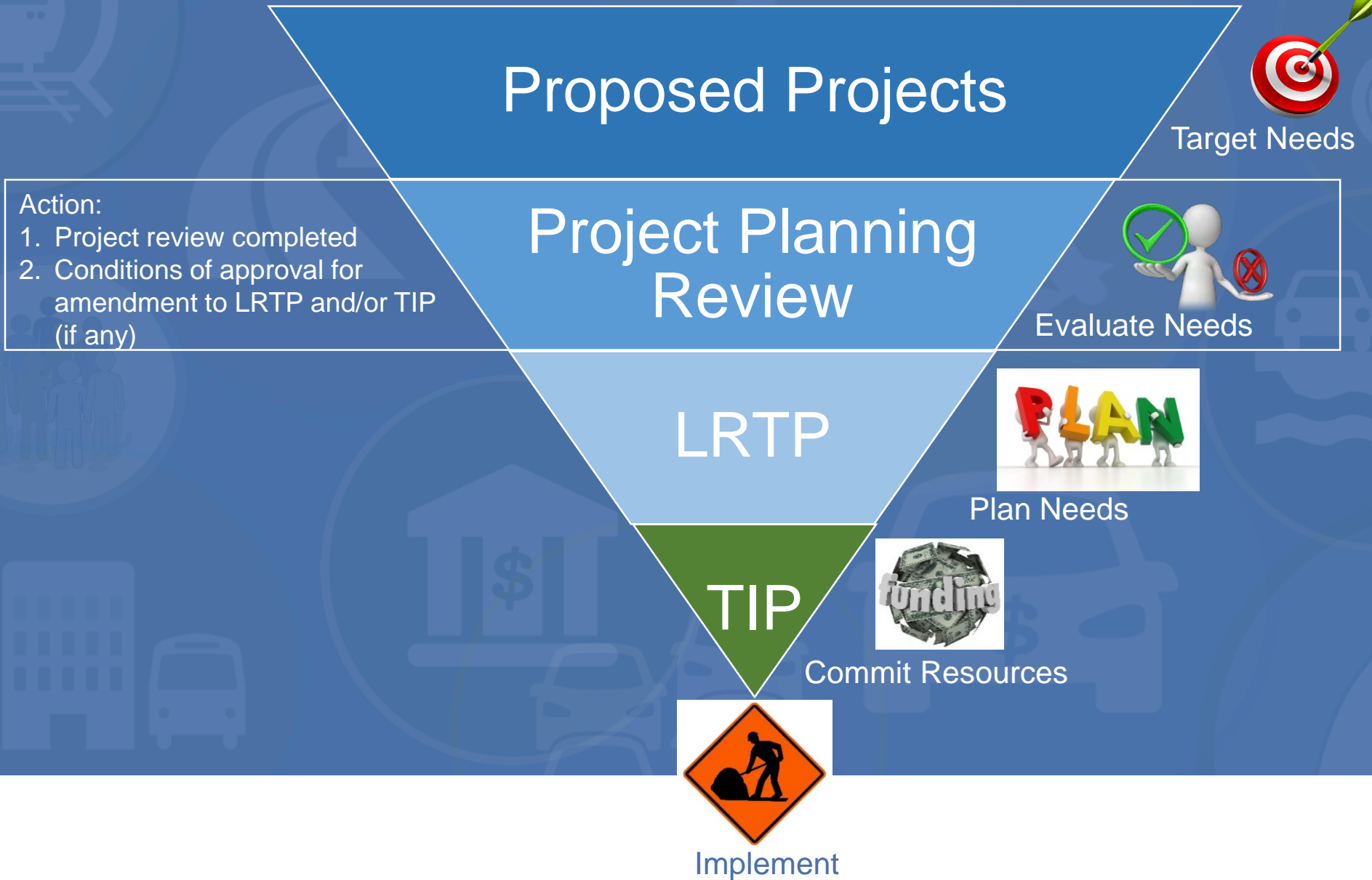
- To assess if a proposed project helps to achieve NOACA vision and goals; and
