# ACTION REQUESTED

Request the Board of Directors adopt the following Resolution:

- 2018-020, which authorizes the Executive Director to execute a contract with selected vendor for Bicycle and Pedestrian Data Collection Equipment

## PREVIOUS ACTION

- December 2017, NOACA board approved Resolution 2017-036 amending OWP to reflect NOACA's Award of \$300,301 from ODOT's Active Transportation Program Grant
- Recommended by Finance and Audit Committee May 2018



# BACKGROUND

- NOACA was awarded a grant to expand its bicycle and pedestrian data collection program by obtaining and installing equipment at 14 permanent locations. The data collection locations will be distributed among 5 counties, and 8 jurisdictions.



# BACKGROUND

- **NOACA requires: equipment manufacturers and vendors that can supply, install, and retrieve data from bicycle and pedestrian data collection equipment**
- **The primary purpose of NOACA's bicycle and pedestrian permanent data collection program is to accurately and continuously count bicycles and pedestrians at specific locations.**

# BACKGROUND

- Selection process:
- IFB released April 13th, 2018
- Proposals/Bids due May 2nd, 2018
- Four bids received
  - One deemed unresponsive
  - One offered lease option only
  - One was determined best and lowest



# BACKGROUND

- Selection Process:
- The selection committee determined that Miovision Technologies, Inc. best met the selection criteria
