

Northeast Ohio Areawide Coordinating Agency (NOACA) Request for Proposals for Hotel Rooms and Event Space For The Ohio Conference on Freight for 2019

Date of Issue: Monday, October 29, 2018 **Submittal Deadline:** Friday, November 16, 2018

The Northeast Ohio Areawide Coordinating Agency (NOACA), in accordance with Title VI of the Civil Rights Act of 1964 and the related nondiscrimination statutes, hereby notifies all bidders that it will affirmatively ensure that any contract entered into pursuant to this advertisement, all bidders including disadvantaged business enterprises will be afforded full and fair opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, national origin, sex, age, disability, low-income status, or limited English proficiency in consideration for an award.

BACKGROUND

The Ohio Conference on Freight attracts professionals from the private and public sectors and from numerous states and provinces in the U.S. and Canada who are deeply involved in freight and the economy.

The conference addresses barriers between each mode that transports goods between the public and private sectors. It is a vital forum to support economic growth in Ohio and the surrounding Great Lakes region through an integrated, multimodal industry.

NOACA, the agency hosting Ohio Conference on Freight in 2019, seeks proposals from firms that specialize in hotel room and event/conference space.

DELIVERABLES

The selected venue would:

- have hotel rooms and event space available during three consecutive days (either a Wednesday, Thursday, and Friday; a Sunday, Monday, and Tuesday; or a Monday, Tuesday, and Wednesday) in August 2019 (preferably the week of August 11, August 18, or August 25, 2019)
- have event space to accommodate between 300 and 400 people
- be located within Downtown Cleveland
- be able to secure a block of hotel rooms (to be paid for by attendees) for the attendees (estimated at 50 guest rooms for the first night and 130 for the second night)
- have hotel rooms within a ten-minute walk to the meeting facility
- have easy access to restaurants and other evening event venues

Meeting Room Needs:

- a large ballroom to hold up to 400 people for three general sessions on three consecutive days
- three break-out rooms, theater style, to hold at least 75 to 100 people each for consecutive breakout sessions on three consecutive days

Anticipated Food Needs:

- continental breakfast
- plated lunch
- vegetarian/vegan and gluten-free options
- snacks and/or beverages for breaks

SUBMISSION INSTRUCTIONS

Hotel brands can propose a quote for all its properties in Downtown Cleveland or just one. The length and format of each proposal is at the discretion of the applicant. A proposed contract is acceptable. To be considered, proposals must be either printed and mailed or emailed in PDF format. Proposals will be received by NOACA until 4:00 p.m. on November 16, 2018.

NOACA reserves the right to accept the Proposal deemed to be in its best interest or to reject any and all Proposals.

The Executive Director of NOACA is the only individual who may legally commit NOACA to the expenditure of public funds. No cost chargeable to the proposed contract may be incurred before receipt of either a fully executed contract or a specific, written authorization to proceed.
