**RESOLUTION OF THE GOVERNING BOARD  
OF THE  
NORTHEAST OHIO AREA WIDE COORDINATING AGENCY**

**WHEREAS**, the Northeast Ohio Areawide Coordinating Agency (NOACA) is the Metropolitan Planning Organization (MPO) for the counties of Cuyahoga, Geauga, Lake, Lorain, and Medina, and the areawide water quality management planning agency for the same region; and

**WHEREAS**, *Clean Water 2000*, the current update to the NOACA Section 208 Water Quality Management Plan, was adopted by the NOACA Governing Board, certified by the Governor of Ohio, and approved by the United States Environmental Protection Agency; and

**WHEREAS**, *Clean Water 2000* provides for modifications to wastewater treatment facility planning area (FPA) boundaries, subject to review by the NOACA staff and the NOACA Water Quality Advisory Committee; and

**WHEREAS**, NOACA has received a request from the Northeast Ohio Regional Sewer District (NEORS D) as a Designated Management Agency to include a portion of a “No Planning Area” in Olmsted Township into the NEORS D Facility Planning Area (FPA) as shown in Attachment A; and

**WHEREAS**, letters of support from the affected jurisdictions have been secured; and

**WHEREAS**, the NOACA Water Quality Advisory Committee has reviewed this request and recommends that the Governing Board approve the boundary changes as agreed to by the affected jurisdictions.

**NOW, THEREFORE, BE IT RESOLVED** by the Governing Board of the Northeast Ohio Areawide Coordinating Agency, consisting of forty-four principal officials serving general purpose local governments throughout and within the counties of Cuyahoga, Geauga, Lake, Lorain, and Medina that:

**Section 1.** The *Clean Water 2000 Plan* is amended to include the area delineated in Attachment A as part of the NEORS D Facility Planning Area.

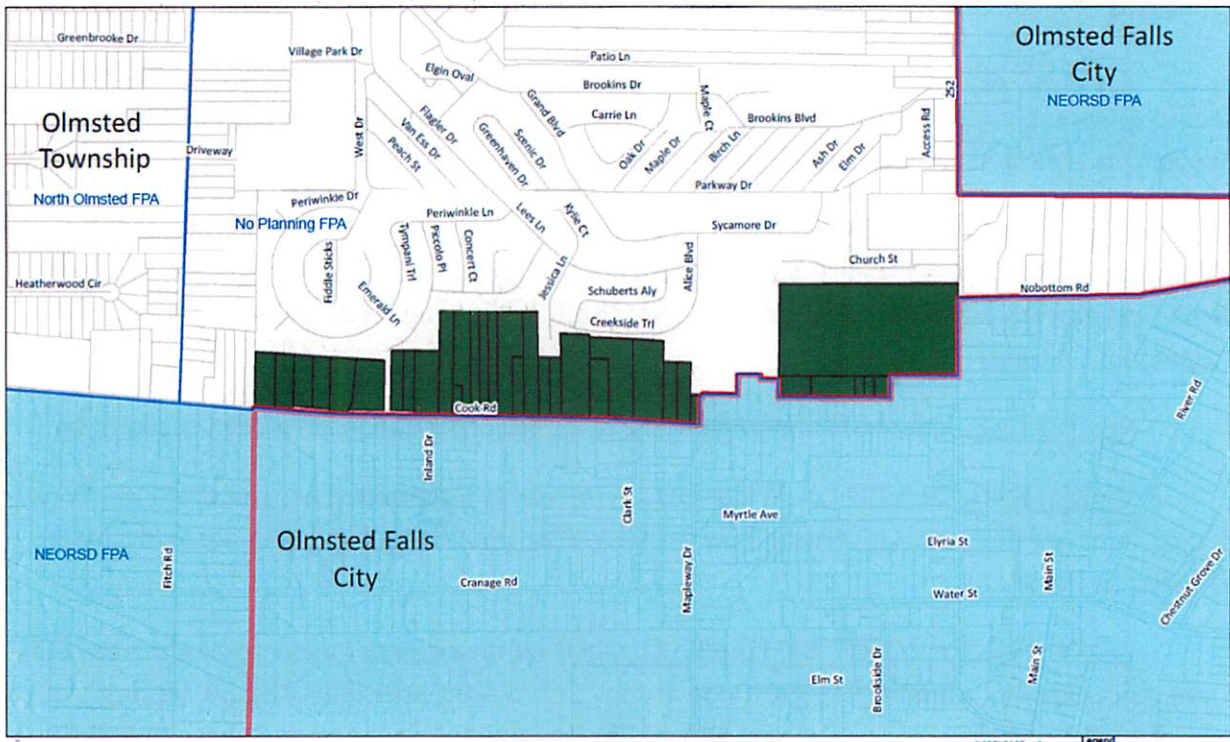
**Section 2.** The Executive Director is authorized to transmit certified copies of this resolution to appropriate federal, state, and local agencies.
