**WHEREAS**, the Northeast Ohio Areawide Coordinating Agency (NOACA) is the Metropolitan Planning Organization (MPO) for the counties of Cuyahoga, Geauga, Lake, Lorain, and Medina, and the areawide water quality management planning agency for the same region; and

**WHEREAS**, Robert (Bob) E. Aufuldish was a Wickliffe councilman for nine years and mayor of Wickliffe for eight years before being elected as Lake County Commissioner in 1996, a position he held for 17 years before retiring at the end of 2014; and

**WHEREAS**, Bob Aufuldish served NOACA for 18 years as a Board member and an officer, as a member of the Air Quality Subcommittee and chair for ten years, and as an active member of the Executive Committee, Transportation Subcommittee (and its precursor, the Transportation Advisory Committee), and Policy Committee; and

**WHEREAS**, Bob Aufuldish served as a member or trustee for about a dozen organizations over the years, including as committee chairman for Boy Scout Troop #84 and a manager for both a boys' and a girls' team in the Wickliffe Baseball League; and.

**WHEREAS**, Lake County has flourished and prospered under Bob Aufuldish's leadership so that it is in financially stable condition; and

**WHEREAS**, Bob Aufuldish worked for 32 years at The Lubrizol Corporation as a research analytical chemist and supervisor before retiring in 1993; and

**WHEREAS**, Bob Aufuldish earned a bachelor of science degree in chemistry from the University of Dayton and a master of science degree in analytical chemistry from Michigan State University; and

**WHEREAS**, Bob Aufuldish served as a Surgical Technician in the U.S. Army Medical Corps; and

**WHEREAS**, Bob Aufuldish has served as a mentor and encouraged others to work together for the good of northeast Ohio, and treats all persons with fairness, openness, and respect.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Directors of the Northeast Ohio Areawide Coordinating Agency, consisting of 45 principal officials serving general purpose local governments throughout and within the counties of Cuyahoga, Geauga, Lake, Lorain, and Medina that a vote of thanks and continued success be conveyed to Bob Aufuldish for his dedication to the development of his community, county, and State, together with best wishes for a prosperous and productive future.
