Resolution No. 2015-040: NOACA SFY 2016 - 2019 Transportation

Improvement Program

ACTION REQUESTED

The Board of Directors is asked to approve the NOACA SFY 2016 - 2019 Transportation Improvement Program (TIP), which consists of the draft dated April 12, 2015 as well as projects subsequently identified and advanced consistent with the long-range transportation.

BACKGROUND/JUSTIFICATION

The TIP contains the program of projects for SFY 2016 through SFY 2019, including projects to be funded with NOACA administered funds and projects financed with other federal funds.

The first draft of the SFY 2016 - 2019 TIP, dated February 2015, was developed through coordination with the project sponsors and program managers for scope and schedule updates. Staff assembled the information into the first draft Transportation Improvement Program (TIP) and submitted it to ODOT, FHWA and FTA for review and comment.

NOACA developed a second draft TIP, dated March 2015, which was utilized for statewide STIP/TIP public participation period, from March 30, 2015 to April 10, 2015. NOACA and ODOT hosted open houses to invite public review and comment on the STIP/TIP documents on the following dates:

- Tuesday, April 7, from 1 p.m. to 6 p.m. at NOACA's offices
- Wednesday, April 8, from 4 p.m. to 7 p.m. at ODOT District 12 (5500 Transportation Blvd., Garfield Heights)
- Thursday, April 9, from 10 a.m. to 6 p.m. at ODOT District 3 (906 North Clark St., Ashland)

Following the STIP/TIP public review period a final draft of the TIP, dated April 2015 was prepared and submitted for ODOT, FHWA and FTA review and approval.

In accordance with NOACA's Public Interaction Policy (2011 Update), the NOACA TIP was required to be available for review and comment through May 15, 2015, but will continue to be available through June 12, 2015.

Projects Programmed with NOACA Administered Funds

The program of projects recommended to be funded with NOACA STP, TAP and CMAQ funds for SFYs 2016 through 2019 was developed by staff and recommended by the respective committees and subcommittees. See attached tables. Each table includes a funding summary and the list of projects programmed for each.

To the maximum extent, projects programmed in SFYs 2016 and 2017 of the current SFYs 2014 - 2017 TIP, remained in their respective years.

In addition to the aforementioned project commitments, the program of NOACA funded projects contains the following regional initiatives:

- 2016 MPO carryover redistribution program
- 2016 Provisional Transportation Asset Management Program (PTAMP) debt-service payments in SFY 2016 through 2019
- Transportation Asset Management Program (TAMP) financing and preliminary draft projects for SFY 2017, 2018 and 2019
- Transportation for Livable Communities Initiative for SFYs 2016 through 2019

Projects considered for NOACA funding in SFYs 2017 through 2019 were evaluated using objective-based criteria that directly promote the vision and goals of the agency, while aligning priorities with State and Federal performance planning initiatives to the extent practicable.

Based on the availability of funds, projects were prioritized according to regional benefits, impact/connectivity and readiness factors as contained in the 2016- 2019 TIP Development Methodology - Implementing Connections* 2035 and through NOACA transportation asset management planning.

The proposed SFY 2016 - 2019 TIP, inclusive of the projects identified for advancement with NOACA administered funds has been recommended by the Transportation Subcommittee, Planning and Programming Committee, and Executive Committee for approval. Also, the Finance and Audit Committee recommended the TIP financial plan for NOACA administered funds at its May 8th meeting.

CONCLUSION/NEXT STEPS

Following Board approval of the SFY 2016 - 2019 TIP, the NOACA-administered funded projects will be incorporated into the statewide TIP amendment in July. The NOACA Board of Directors Resolution No. 2015-040 adopting the SFY 2016 - 2019 TIP will be forwarded to ODOT, FHWA and FTA to be included with the TIP for review and approval effective July 1, 2015.

Ozone and PM2.5 Conformity Analyses for Transportation Plans, Programs, and Projects in the Cleveland-Akron-Lorain, Ohio Metropolitan Area

Akron Metropolitan Area Transportation Study (AMATS)
Northeast Ohio Areawide Coordinating Agency (NOACA)
City of Vermilion, Lorain County portion

What is required?

Nonattainment areas, through a process called transportation conformity, are required to demonstrate that emissions resulting from planned transportation system improvements will not exceed an area's emissions budgets. The US Department of Transportation (US DOT) issues nonattainment areas formal transportation conformity determinations following a quantitative analysis demonstrating that emissions from vehicles traveling on the planned transportation system are less than the area's emissions budget (or other emission target in the absence of an approved budget). Transportation conformity determinations ensure that the transportation sector is contributing to an area's progress toward meeting national air quality standards.

The Metropolitan Planning Organizations (MPOs) and the Ohio Department of Transportation (ODOT) must reestablish conformity for the 1997 and 2006 fine particulate matter standards and for the 1997 and 2008 8-Hour ozone standard as a result of the adoption of SFY 2014-2017 Transportation Improvement Programs and long range transportation plan amendments. Because conformity is determined on a nonattainment area, rather than a sub area basis, each of the area's planning partners must approve a new conformity finding for the area based on these updates. The analysis for each standard covers the pertinent portions of the counties of Ashtabula, Cuyahoga, Geauga, Lake, Lorain, Medina, Portage and Summit. The current analyses reflect a comparison of projected transportation emissions against the approved budgets for each standard.

Why are these tests required?

These tests are required because all areas with a current or former designation of nonattainment must maintain conformity findings for the designated pollutants. The tests ensure that transportation planning efforts are not hindering efforts to bring the area into attainment of the standards or maintain attainment of the standards.

What tests are being conducted?

The first test is a comparison of projected emissions against the draft budgets for ozone precursors (volatile organic compounds (VOC's) and nitrous oxides (NOx)).

The second test is a comparison of projected emissions with draft budgets for fine particulates and nitrous oxides (NOx).

For all tests, projected emission levels beneath the respective budgets is considered conformance with the goals of the Clean Air Act.

What are the results of the tests?

The results of the tests, as displayed in the following Tables, are that the area's existing plans, programs, and projects meet the conformity requirements.

RESOLUTION NO. 2015-040 (SFY 2016 - 2019 TRANSPORTATION IMPROVEMENT PROGRAM)

RESOLUTION OF THE BOARD OF DIRECTORS OF THE NORTHEAST OHIO AREAWIDE COORDINATING AGENCY

<u>WHEREAS</u>, the Northeast Ohio Areawide Coordinating Agency (NOACA), as the metropolitan planning organization (MPO) for the five Northeast Ohio counties of Cuyahoga, Geauga, Lake, Lorain, and Medina, is presently engaged, through Board of Directors action and staff technical work, in the continuing phase of the cooperative, comprehensive, and continuing (3C) planning process designed to meet needs, requirements, goals, and objectives of national, state, and local governmental levels, all within this nation's federal transportation system; and

<u>WHEREAS</u>, the Congress of the United States, through law, and the U.S. Department of Transportation, through regulation, have determined that a Transportation Improvement Program (TIP) shall be prepared, which includes federal-aid transportation projects expected to be implemented in each of the program years; and

<u>WHEREAS</u>, the NOACA State Fiscal Year (SFY) 2016-2019 Transportation Improvement Program (TIP) was prepared in conformance with the NOACA Regional Transportation Investment Policy and, as such, is consistent with the above guidance and regulation; and

<u>WHEREAS</u>, the TIP has been processed through public involvement, consistent with the Board of Directors Public Interaction Policy and Participation Plan; and

<u>WHEREAS</u>, following the STIP/TIP public review period a final draft of the TIP, dated April 12, 2015 was prepared and submitted for ODOT, FHWA and FTA review and approval.

<u>WHEREAS</u>, the Transportation Subcommittee and Planning and Programming Committee and Executive Committee, in reviewing the draft TIP have found that it has met the federal, state, and local requirements for fiscal balance, public involvement and public participation, and recommends its approval; and

<u>WHEREAS</u>, during the development of the TIP, projects previously amended to the plan with NOACA-administered funds were recommended to be advanced from the plan for funding in the TIP for SFYs 2016 through 2019;

<u>WHEREAS</u>, the recommended NOACA-administered funded projects had not yet been approved by the Board of Directors, so they were not included in the final draft TIP dated April 12, 2015.

<u>WHEREAS</u>, the recommended NOACA-administered funded projects are listed in Attachment 1.

RESOLUTION NO. 2015-040 (SFY 2016 - 2019 TRANSPORTATION IMPROVEMENT PROGRAM)

WHEREAS, the Clean Air Act Amendments of 1990 require that NOACA make a determination, in cooperation with AMATS, ERPC and ODOT, that the SFY 2016 - 2019 TIP is in conformity with respect to Ohio's State Implementation Plan for attainment of the 2008 8hour ozone standard and the 1997 annual and 2006 daily fine particulate matter standards; and

WHEREAS, NOACA staff have completed the necessary transportation conformity analyses for the five counties and combined them with the analyses for the rest of the applicable nonattainment areas; and

WHEREAS, the results of the analyses (Attachment 1) demonstrate that NOACA's long-range transportation plan, Connections 2035 and the SFY 2016 - 2019 TIP for the area remains in conformance with the intent of Ohio State Implementation Plans (SIPs); and

WHEREAS, in accordance with Moving Ahead for Progress in the 21st Century (MAP-21), NOACA and ODOT are carrying out their responsibilities under applicable provisions of federal law.

NOW, THEREFORE, BE IT RESOLVED by the Board of Directors of the Northeast Ohio Areawide Coordinating Agency, consisting of forty-four principal officials of general purpose local government throughout and within the counties of Cuyahoga, Geauga, Lake, Lorain, and Medina that:

Section 1: The NOACA SFY 2016-2019 Transportation Improvement Program, consisting of the draft dated April 12, 2015 as well as projects subsequently identified and advanced consistent with the long-range transportation plan.

Section 2: The urban transportation planning process is being carried out in conformance with all applicable federal requirements.

Section 3: The Executive Director is hereby authorized to transmit a certified copy of this resolution and other appropriate documentation to federal, state, and local agencies.
