RE: Resolution 2015-039 – Fiscal Year 2016 Annual Priority List

ACTION REQUESTED

The Board of Directors is asked to approve the priority list of projects to be funded in State Fiscal Year (SFY) 2016 with NOACA administered funds.

BACKGROUND/JUSTIFICATION FOR CURRENT ACTION

The SFY 2016 Annual Priority List (APL) (attached) contains projects to be funded in state fiscal year 2016 with NOACA allocated Surface Transportation Program (STP), Congestion Mitigation and Air Quality (CMAQ) and Transportation Alternative Program (TAP) funds. NOACA staff, ODOT Districts, and the project sponsors all concur that these projects are ready and able to use the identified funding amounts during the next fiscal year.

All of the projects in the SFY 2016 APL have been processed through NOACA's project planning review (PPR) and have been amended to NOACA's Long Range Transportation Planand the Transportation Improvement Program (TIP).

The SFY 2016 APL includes projects for which the Board of Directors previously has committed funding in the fiscal year 2014 – 2017 TIP dated May 10, 2013. The list also includes projects for which schedules were revised for inclusion in SFY 2016 as a reservoir project per sponsor input and NOACA concurrence.

The priority list includes two previously approved high-cost projects portrayed as State Infrastructure Bank (SIB) funded as a means to maintain fiscal balance and flexibility while enabling the projects to advance into the TIP during the year requested by the sponsors.

The projects that are using SIB loans are:

- PID No. 10900 CUY BAGLEY/PLEASANT VALLEY RD (debt service)
- PID No. 16319 LOR LEAR NAGLE RD (project financing)

PID No. 10900 was awarded in SFY 2014. The first debt-service payment is due in SFY 2016.

The estimated award for PID No. 16319 is SFY 2016 and a SIB loan agreement is anticipated to be executed for it. Although its first debt payment is not due until SFY 2018, it must appear in the annual priority list because 2016 is its year of construction.

The NOACA Transportation Subcommittee, Planning and Programming Committee and the Executive Committee have reviewed the SFY 2016 Annual Priority List and have recommended its approval.

FINANCIAL IMPACT

The total cost of the projects is approximately \$85 million with approximately \$30 million of NOACA administered funding committed. The projects are consistent with current financial forecasts, plans and budget constraints.

CONCLUSION/NEXT STEPS

Following Board adoption, staff will work with project sponsors toward the successful delivery of the projects and management of the programs.

RESOLUTION OF THE BOARD OF DIRECTORS OF THE NORTHEAST OHIO AREAWIDE COORDINATING AGENCY

<u>WHEREAS</u>, the Northeast Ohio Areawide Coordinating Agency (NOACA) is the Metropolitan Planning Organization (MPO) for the counties of Cuyahoga, Geauga, Lake, Lorain, and Medina, and the areawide water quality management agency for the same region; and

<u>WHEREAS</u>, the Congress of the United States, through law, and the U.S. Department of Transportation, through regulation, have determined that a long-range twenty-year transportation plan and a four-year Transportation Improvement Program (TIP) shall be prepared, which includes federal-aid transportation projects expected to be implemented in each of the program years; and

<u>WHEREAS</u>, the NOACA State Fiscal Year (SFY) 2016-2019 TIP was prepared in conformance with the NOACA Board of Directors' Regional Transportation Investment Policy and, as such, is consistent with the above guidance and regulation; and

<u>WHEREAS</u>, the NOACA Regional Transportation Investment Policy requires that all proposed federal-aid transportation projects be processed through project planning review in order to meet Transportation Plan goals and federal requirements; and

<u>WHEREAS</u>, the list of priority projects for SFY 2016 (Attachment 1) using NOACA attributable funds was developed in conformance with the Regional Transportation Investment Policy; and

<u>WHEREAS</u>, the Transportation Subcommittee, Planning and Programming Committee and the Executive Committee have reviewed the SFY 2016 Annual Priority List and have recommended their approval.

<u>NOW, THEREFORE, BE IT RESOLVED</u> by the Board of Directors of the Northeast Ohio Areawide Coordinating Agency, consisting of forty-five principal officials serving general purpose local governments throughout and within the counties of Cuyahoga, Geauga, Lake, Lorain, and Medina that:

Section 1. The NOACA SFY 2016 Annual Priority List (as listed in Attachment 1) is approved.

<u>Section 2</u>. The costs of the projects are the "not to be exceeded amounts" of NOACA attributable funds. If the project exceeds the amount listed at the time of filing the Plans, Specifications and Estimate (PS&E), the increase in cost will be borne by the project sponsor.
